Terms and Conditions

- 1. The appointment is purely on contract basis till 31.03.2025. Contract to be renewed every year depending on performance.
- 2. The consolidated remuneration will be Rs 35,000/- per month.
- 3. The appointment can also be terminated at any time on either side by giving one month's notice or by paying one month's salary, without assigning any reason or failure to complete the period of three months to the satisfaction of the competent authority.
- Initial induction training and orientation in Renal Transplant will be done at NOTTO and Dept. Of Nephrology, Safdarjung Hospital, New Delhi, followed by retraining at periodic intervals.
- 5. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowance will be admissible in case of such assignment.
- 6. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, LTC, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government servants appointed on regular basis.
- 7. Non-practicing Allowance will not be admissible to Medical graduates.
- 8. Selected candidate will not be provided any residential accommodation by Safdarjung Hospital/MOHFW.
- 9. The appointee will not be granted any claim or right for regular appointment to any post under Central Health Service.
- 10. The appointee shall be on the whole time appointment of the Institution and shall not accept any other appointment, paid or otherwise and shall not engage himself/herself in private practice of any kind during the period of contract.
- 11. No premature publicity through interviews/write-ups etc. should be given in individual capacity by transplant co-ordinator without permission
- 12. The appointment to the said post will be subject to physical fitness from the competent medical board for which he will be sent to the designated Medical Authority by the concerned Institution before joining the post.
- 13. The leave entitlement of the appointee shall be governed in terms of instructions contained in DOP&T OM No.12016/3/84-Estt.(L), dated the 12th April, 1985, as amended by OM No.12016/ I/96-Estt.(L) dated the 5th July, 1990.
- 14. The appointee is not entitled to any TA for joining the appointment.
- 15. Other conditions of service will be governed by relevant rules and orders issued from time to time.
- 16. If any declaration given or information furnished by him proves to be false or if he/she is found to have will fully suppressed any material information, he/she will be liable for removal from service and also such other action as the Government may deem necessary.
